1. OVA Talk: Are We Doing Enough to Help Nature in the Climate Crisis?

Olly has been at the forefront of adaptation for nature at national and international levels, working with NGOs and governments. His talk will ask 'are we doing enough, and what can we do better to help nature thrive as it faces its greatest long-term threat?'

Tuesday 1 October – 10.00am sharp – 7 miles. 4 hours plus lunch 'Around Kilmington'

Kilmington - taking in Shute Hill, Shute Barton, Yarty and Axe Flood Plain. The morning walk is a circular 3.5 miles passing through woods and Shute Barton, mainly on forest tracks and quiet rural roads, short section through farmland. 3. Initiative Update: Water Quality

The water quality group met last week (our first meeting since the summer holidays). We discussed the five major initiatives within this group:

Group 1 Feedback: Water testing

Background:

We will look to build on current water quality testing on the River Otter undertaken by the Environment Agency and Westcountry Rivers Trust Citizen Scientists. Investigate the means of funding the purchase of up-to-date monitoring equipment.

Outcomes from meeting:

- We have identified four sources of data for further analysis (SWW, DWT, Citizen Scientists, EA).
- We want to obtain the raw data to allow us to identify actual details and cross-reference across sources.
- DWT are giving us two Eggs to test phosphates at places to be selected by us. Suggestions made during the
 meeting include under the new white bridge (to look at reserve water) and the old white bridge (to look at the river).
- We believe testing should take place at relevant SWW points of interest (e.g.: Honiton sewage works).

 We want to engage with Clinton Devon Estates to request that water quality is included in the new "Heaths to Sea" project.

Group 2 Feedback: Agricultural runoff

Background: We will consider how best to encourage good farm practices by liaising with Clinton Devon

Estates, Westcountry Rivers Trust, the Environment Agency, National Farmers Union, Bicton

Agricultural College and other relevant organisations.

Outcomes from meeting:

- lorwerth (Yog) Watkins from the Devon Wildlife Trust has agreed to give a talk on "Farming Practices" for the OVA in February 2025.
- We discussed the role this group can have to raise awareness of this cause of pollution to the river.
- The fate of farmers is influenced by this topic and ultimately needs parliament to engage and mandate approaches. Hence, we need to talk to our MP's (E.g.: David Reed).

Group 3 Feedback: South West Water and EA

Background: We will challenge and hold SWW to account for pollution in the River Otter catchment and

neighbouring coastline that they are directly responsible for. We will monitor the Environment Agency to ensure they are fulfilling their legal responsibilities.

Outcomes from meeting:

• We want to support other groups who are also campaigning for cleaner water.

- We want to analyse the data on sewage discharges from SWW at relevant points up the river Otter.
- We want to understand how sewage discharged into Budleigh Bay comes back up the river and into the Nature Reserve when moving from low tide to high tide? To this end, a "Citizen Scientist" project was suggested to investigate this we are looking for volunteers to help us with this project.
- We want to understand (and influence?) plans for new housing developments e.g.: where is the sewage going, and how will it be handled, from the new town being planned just south of Exeter airport? Are there plans to build new sewage processing plants, or to move it through new pipes to the coast? We would like to understand and share.

Group 4 Feedback: Partnerships

Background: We will identify and engage with any individuals or organisations that are relevant to the goals of

this group.

Outcomes from meeting:

 We will create a simple database of all organizations we want to be affiliated to, plus any contacts that we know of or want to engage with. For example: Citizen Scientists, Westcountry Rivers Trust, Environment Agency, River Otter Fisheries Association, East Devon Catchment Partnership.

Group 5 Feedback: Planning

Background:

We will review and contribute to local and national planning policies to understand and influence how additional building will impact on the management of sewage and other pollution sources.

Outcomes from meeting:

- We want to use the planning expertise of the OVA to understand plans from SWW, and others, for infrastructure and sewage capabilities for new development works.
- We want to ensure that any new development has sewage and other infrastructure requirements implemented before development work occurs.

4. Initiative Update: Flora & Fauna

Our inaugural meeting will be taking place at the Kings Arms pub in Otterton at 7pm on Tuesday 1st October. Everyone is welcome to attend. Our initial charter for this group is as follows:

- To document the range of flora and fauna in the valley focusing perhaps on residents, aliens, rare or unusual species.
- To produce and publicise materials to help with the well-being of insects, birds, animals and plants (e.g.: leaflets, booklets, web-pages Etc).
- To encourage participation of adults and children in enjoying the flora and fauna (walks, talks, school efforts, photography competitions etc).
- To help protect and enhance our flora and fauna where necessary planting trees, protecting hedgerows, protecting rare examples, Etc.
- To work with partners to help protect the habitat (working with farmers on run-off, or to identify and help remove invasive species etc).
- To understand and highlight the impact of climate change on our environment in the valley.

8. External Programmes

A busy week at the end of September:

- Your chair was interviewed on-line by a Cambridge student writing a thesis on the 'people aspects' of the LORP scheme.
- Then environmental member Geoff Porter attended (and the chair joined on-line) a meeting of the "Heaths to Sea" advisory group of Clinton Devon Estates (CDE). This has become one of several pilot schemes nationally looking at how land can be better used for both agriculture and nature. Having been successful in the initial bidding process, CDE have commissioned 3 groups of consultants whose task is to survey and evaluate their land in and around the Lower Otter Valley. They are evaluating the quality of grasslands, arable land, woodlands, hedgerows, hydrological assessments of ditches, streams and the River Otter and identifying heritage and archaeological sites within the estate. Future decisions about how and where improvements can best be made will be based on these detailed surveys. Proposals will be made to Government in 18 month's time
- The following day the chair attended, on behalf of the OVA, the East Devon National Landscape Stakeholder Workshop set up by the new manager Dan Wynn as a brain-storming exercise by all the various stakeholders to help him shape the next 5-year landscape management plan. Lots of ideas shared on everything from planning to climate to river water quality, and with the emphasis on community involvement. Most ideas fitting well with the OVA's objectives. We wait with interest to see how the plan emerges.
- And just for 'light(!)' bedtime reading we are trying to digest the multi-page Civic Trust's response to the NPPF
 (National Planning Policy Framework). This is part of a nationwide consultation which has generated thousands
 of responses and looks like it will run and run.

We have also been invited to participate in two programmes by the Pebblebed Heaths team and by East Devon District Council – the first is the Wetlands Weekend (18th to 20th October), and the second is a program looking at the wild and changing estuaries of the Exe, Otter & Axe.

Wetlands Weekend - 18th to 20th October

The OVA has been invited to host a display and have a presence at the upcoming wetlands weekend. We will be
there but are looking for a few volunteers to help man the stand. If you can help, please do let us know in the usual
manner.

EDDC Request for engagement

The Arts and Culture East Devon (ACED) will work with three East Devon Coastal Museums (Exmouth, Fairlynch and Axe Valley) to unlock collections of natural science and biodiversity. Digitisation of photographs, cartography and paintings capturing the wild and changing estuaries of the Exe, Otter & Axe will improve access to collections. Reinterpretation of these collections via engagement with local secondary schools (Exmouth Community College and the Deaf Academy) will engage new audiences in national conversations about the climate crisis. This group has reached out to the OVA asking for support and involvement. We are working with them to determine the scope and capability to be offered.

Our participation in these two programs is dependent upon volunteers. We are asking for people to help man the stand at the Wetlands Weekend, as well as engaging with EDDC and the local museums on their program. IF you have time and the inclination to help – please do reach out and contact us.

Water quality on the river Otter is a major initiative for the OVA. Farm runoff, sewage discharges and other pollutants are the major causes of the degradation we see in our river water quality. These are also affecting many of our waterways, rivers and oceans to such an extent that many members have told us that they want their voices heard. We are also aware that a number of OVA members are planning to attend in their **personal** capacity

We also wanted to share with you all a few specific organisations who are campaigning to drive improvements and accountability into the water industry. Several of our members are involved and support these groups. We wanted to share information about these groups for you to be aware of. These include:

- 1. ESCAPE (https://www.facebook.com/groups/exmouthescape/) that is campaigning for improved water quality in Exmouth and surrounding towns.
- 2. River Action UK (https://irveractionuk.com) is a small and agile campaigning organisation on a mission to rescue Britain's rivers from a cocktail of agricultural, sewage and industrial pollution.
- Surfers against sewage (<u>https://www.sas.org.uk</u>) is a charity that campaigns for a clean ocean, rivers and lakes for wildlife and people. They demand an end to sewage discharge into UK bathing waters by 2030.
- 4. The rivers trust (https://theriverstrust.org/) is a charity that work with their member trusts to make their shared vision a reality: wild, healthy, natural rivers, valued by all.
- Wildfish (https://wildfish.org) is a charity whose mission is to reverse the decline of wild fish populations and their habitats.

6. River Otter Fisheries Association (https://www.riverotterfisheriesassociation.org/) represents anglers, riparian and fishing right owners on the River Otter in Devon, working to protect and improve the river's environment, wild fish stocks and fishing.

12. Planning Applications

The OVA Executive Committee monitors and comments on some planning applications. We are particularly interested in applications that may affect the character and heritage of the valley. While we may support or object to various applications, there is nothing to stop anyone else from adding their own voice to the discussion. The EDDC planning officer will review any comments made and take them into consideration when applications are determined.

We wanted to draw to your attention two applications in Budleigh Salterton that may be of interest:

- The replacement of an existing single family dwelling and creation of 4 apartments at 10 Marine Parade in Budleigh Salterton (reference: 24/1832/FUL)
- The retrospective application for cladding to be placed on the historical longboat building on Marine Parade. Both applications are within defined conservation areas (reference: 24/1635/FUL).
